The platform is designed to reflect how regulators in the GCC draft, publish, interpret, and enforce laws and supervisory expectations.

Unlike traditional compliance tools developed primarily for Western regulatory environments, Regulynx is purpose-built for the Middle East. It is the first RegTech platform to be fully Arabized across its entire compliance lifecycle: from Arabic source legislation → to regulatory obligations → to policies, controls, and compliance reporting.

At the core of the platform is a verified regulatory rule library derived directly from Arabic source law, ensuring legal traceability, accuracy, and auditability. Regulynx also features an AI-powered regulatory assistant (“RegBot”), automated policy and control mapping, and real-time compliance dashboards aligned with regional supervisory practices.

“Most compliance platforms treat Arabic law as an afterthought or a translation problem,” said *Chantal Felter-Zeegelaar*, CEO at Regulynx. “Regulynx has been built from the ground up as a GCC-native and fully Arabized RegTech platform. Besides English, we enable institutions to move directly from Arabic legislation to operational compliance, with confidence, clarity, and speed.”

The launch of Regulynx marks a major milestone in regional RegTech innovation and aligns with Qatar’s broader vision to strengthen regulatory infrastructure, financial sector resilience,

and digital transformation. By providing a GCC-native compliance operating system, Regulynx aims to reduce regulatory friction, improve transparency, and enhance compliance maturity across regulated industries.

Regulynx is currently engaging with financial institutions, telecom operators, and regulated enterprises across Qatar and the wider GCC. Pilot programs are underway, with early adopters using the platform to assess regulatory obligations, generate policies, and monitor compliance status in real time.
